Dear Mr. Smart,

At its February 2017 Mid-Year Meeting, the American Council for Construction Education (ACCE) Board of Trustees reviewed the application for renewal of accreditation of the Construction Management Program at Missouri State University. The Board had available to it the reports of its Visiting Team under the Chairmanship of Mr. John Gaver, and its Accreditation Committee under the Chairmanship of Dr. John Schaufelberger. This letter is to inform you that the Board has voted for a six-year accreditation from February 2017 through February 2023.

A renewal of accreditation visit at the end of this six-year period should be scheduled between September 1 and November 1, 2022. The self-evaluation study, in preparation for this visit, will be due in the ACCE national office no later than June 1, 2022.

The final report of the Visiting Team, as acted upon by the Board, is enclosed. This report, as do all ACCE accreditation reports, contains a delineation of perceived program Strengths, Weaknesses, Concerns, and Undeveloped Potentials. It is the hope of ACCE that the cited Weaknesses and Concerns will be addressed in coming years, while maintaining program Strengths and pursuing program potentials.

All programs are required to file a third year progress report, making your third year progress report due no later than December 1, 2019. A Progress Report form designed specifically for your program will be sent to the program in June of the corresponding year. If for any reason these dates need to be changed, we will notify you well in advance, and should it become necessary for you to ask for an extension, we request that you do the same.

The Board of Trustees looks forward to a Third Year Progress Report containing documented progress toward correcting the Weaknesses and Concerns cited in the current Visiting Team Report. The Board's comments are summarized below:

The Council approves the re-accreditation of the Program at Missouri State University for six years with third year progress report. The Program is to be congratulated for having no Weaknesses noted in the past two site visits. The Council looks forward to learning of progress on hiring the needed faculty member in the third year progress report.

The ACCE Board of Trustees extends congratulations on this accreditation, and asks that I express its appreciation for the many courtesies extended to our Visiting Team and for the positive way in which your faculty and staff responded throughout.
